SECTION 14(1) OF THE ROAD TRAFFIC REGULATION ACT 1984

THE COUNTY OF WILTSHIRE (VARIOUS ROADS, VARIOUS PARISHES) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER (No.52) 2024 (Ref TTRO 9838)

Notice is hereby given that Wiltshire Council has made an Order to close temporarily, to all vehicles, the lengths of roads specified in the Schedule to this notice.

The order is required to enable carriageway patching, surface dressing and associated maintenance works and will be operative from the 04 November 2024 for a maximum period of 18 months. The closures are anticipated to be for up to 5 days but only when traffic signs are in position and only for so long as is necessitated by the works.

It is anticipated that advance signs will be deployed 2 weeks prior to the closure dates. Access will be maintained where possible although delays are likely due to the nature of the works.

The closures are anticipated to take place between 04 November 2024 and 03 January 2025.

1. **A360 (Part), West Lavington**; from its junction with Rutts Lane to its junction with C31.
2. **Lacock Road (Part), Corsham**; from its junction with B3353 to its junction with Ladbroke Lane.
3. **C169 (Part), Atworth**; from its junction with B3109 to its junction with C231.
4. **C214 (Part), Monkton Farleigh**; from its junction with Rushmead Lane to its junction with Link Lane.
5. **Blackberry Lane, Winsley**; from its junction with B3108 to its junction with C237.
6. **Stormore, Dilton Marsh**; from its junction with B3099 to its junction with Clearwood.
7. **Drynham Lane (Part), Trowbridge**; from its junction with Drynham Road to outside its property known as Drynham Lodge.
8. **Mill Lane, Broughton Gifford**; from its junction with The Street to its junction with B3107.
9. **Mons Lane (Part), Lacock**; from outside its property known as No.31 Mons Lane to its junction with Bewley Lane.
10. **Bewley Lane (Part), Lacock**; from its junction with Mons Lane for a distance of approximately 800m in an easterly direction.
11. **Bewley Lane (Part), Lacock**; from its junction with Mons Lane to its junction with Bowden Hill.
12. **East Street, Lacock**; from its junction with West Street to its junction with High Street.
13. **UC 876402 (Part), Broughton Gifford**; from its junction with C212 for a distance of approximately 300m in a northerly direction.
14. **UC 825403 (Part), Southwick**; from its junction with Hoopers Pool for a distance of approximately 525m in a south easterly direction.
15. **Clearwood, Dilton Marsh**; from its junction with Stormore to its junction with B3099.
16. **C250 (Part), Bromham**; from its junction with A342 to its junction with A3102.
