**SECTION 14(1) OF THE ROAD TRAFFIC REGULATION ACT 1984**

**THE COUNTY OF WILTSHIRE (VARIOUS ROADS, VARIOUS PARISHES) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER (No.23) 2023** (Ref TTRO 8935)

Notice is hereby given that Wiltshire Council has made an Order to close temporarily, to all vehicles, the length of road specified in the Schedule to this notice.

The Order, which previously came into operation on 31 July 2023 will now recommence on 04 October 2023. It is required to enable carriageway micro asphalt dressing and associated maintenance works. The Order has a maximum duration period of 18 months.

It is anticipated that advance signs will be deployed 2 weeks prior to the closure dates. Access will be maintained where possible although delays are likely due to the nature of the works.

The closures are anticipated to take place between 04 October 2023 and 31 October 2023

**Schedule**

1. **White Lion Park, Malmesbury** from its junction with Parklands for its entire length.
2. **Chestnut Springs, Lydiard Millicent**; from its junction with The Street for its entire length.
3. **Arundel Close, Chippenham**; from its junction with Conway Road for its entire length.
4. **Tern Close, Calne**; from its junction with Prince Charles Drive for its entire length.
5. **Rowde Court Road, Rowde**; from its junction with Sands Lane to its junction with B3101.
6. **Sands Close, Rowde**; from its junction with Rowde Court Road for its entire length.
7. **Elm Close, Rowde**; from its junction with Rowde Court Road for its entire length.
8. **Walnut Close, Rowde**; from its junction with Rowde Court Road for its entire length.
9. **Chestnut Close, Rowde**; from its junction with Rowde Court Road for its entire length.
10. **St Matthews Close, Rowde**; from its junction with Rowde Court Road for its entire length.
11. **Blackberry Lane, Potterne**; from its junction with A360 for its entire length.
12. **North End Gardens, Sherston**; from its junction with Knockdown Road to its junction with Sandpits Lane.

**Alternative routes**

- 1 – 4. **No alternative route is available.**
5. via B3101 – A342 – Sands Lane and vice versa.
- 6 – 11. **No alternative route is available.**
12. via Sandpits Lane – Knockdown Road and vice versa.
