THE COUNTY OF WILTSHIRE (VARIOUS ROADS) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER (No.22) 2022 (Ref: TTRO XXXX)

Notice is hereby given that Wiltshire Council intends to make an Order to close temporarily, to all vehicles, the lengths of road specified in the Schedule to this notice.

The Order is required to enable carriageway surface dressing and associated maintenance works and will be operative from the 14 November 2022 for a maximum period of 18 months. The closures are anticipated to be for up to 5 days but only when traffic signs are in position and only for so long as is necessitated by the works.

It is anticipated that advance signs will be deployed 2 weeks prior to the closure dates. Access will be maintained where possible although delays are likely due to the nature of the works.

Closures 1 and 2 are anticipated to take place between 14 November 2022 and 19 December 2022.

Closures 3 – 7 are anticipated to take place between 3 January 2022 and 17 February 2022.

Schedule

1. Ladbrooke Lane, Corsham; from its junction with B3353 to its junction with Lacock Road.

2. a) Church Road, Heywood; from its junction with A350 to its junction with Dursley Road.
b) Dursley Road, Heywood; from its junction with B3097 to its junction with Dursley Road.

3. B3109 (Part), Box, South Wraxall and Bradford Leigh; from its junction with A365 to a point approximately 400m south of its junction with Chalfield Road.

4. West Ashton Road, West Ashton; from its junction with A350 to its junction with Leap Gate.

5. A361 County Way, Trowbridge; from its junction with A363 to its junction with Longfield Roundabout.

6. B3105 (Part), Bradford on Avon; from its junction with A363 to its junction with B3109.

7. B3098 (Part), Little Cheverell; from its junction with High Street to its junction with A360.

- 1. via B3353 Lacock Road.
- **2.** via A350 A363 B3097.
- **3.** via B3109 B3105 A363 A365.
- 4. via West Ashton Road (unaffected length) A361 A363 A350.

5. via A361 (unaffected length) - A350 - A363.

6. via A363 – B3109 – B3107 – B3105 (unaffected length).

7. via B3098 (unaffected length) – A350 – A36 – A303 – A360.
