NOTICE IS HEREBY GIVEN that to enable Openreach to carry out utility works ("the Works"), Cumberland Council intends to make an Order the effect of which is to prohibit any vehicle from proceeding along the following sections of road:

1. Highwood Crescent, Carlisle from a point approx. 85m south of its junction with Cumwhinton Road, extending in a southerly direction for approx. 75m.

Alternative Route: via the unrestricted section of Highwood Crescent and Hopes Hill Drive.

Duration: From 13 November 2023 for approx. 1 day (Ref: TTROC/8668)

2. U1218 Highbridge, near Stockdalewath, from its junction with the U1145, extending in a north easterly direction for approx. 270m.

Alternative Route: via the unrestricted section of the U1218, C1018 and the U1145

Duration: From 24 November 2023 for approx. 1 day (Ref: TTROC/8672)

3. Waldegrave Road, Longsowerby, Carlisle from its junction with Ferguson Road, extending in a south westerly direction for approx. 35m.

<u>Alternative Route</u>: via the unrestricted section of Waldegrave Road, Prescott Road and Ferguson Road

Duration: From 27 November 2023 for approx. 1 day (Ref: TTROC/8821)

4. Winscale Way, Carlisle from its junction with Levens Drive to its junction with Greenside Road. Alternative Route: via Greenside Road, Rashdall Road and Levens Drive

Duration: From 28 November 2023 for approx. 1 day (Ref: TTROC/8718)

5. Coney Street, Currock, Carlisle from its junction with Adelphi Terrace to its junction with Lund Crescent.

<u>Alternative Route</u>: via the unrestricted sections of Coney Street, Lediard Avenue, Currock Road and Adelphi Terrace

Duration: From 6 December 2023 for approx. 1 day (Ref: TTROC/8829)

A way for pedestrians and dismounted cyclists will be maintained at all times

Nothing in the Order to which this notice relates shall:

- (i) Apply emergency service vehicles, or vehicles being used by statutory undertakers in the performance of their duties; and
- (ii) Apply to anything done with the permission or at the direction of a police constable in uniform; and
- (iii)Have the effect of preventing at any time access for pedestrians to any premises situated on or adjacent to the roads, or to any other premises accessible for pedestrians from, and only from the roads; and
- (iv)Apply to vehicles being used in connection with the Works.
