## CUMBERLAND COUNCIL (VARIOUS IN THE CUMBERLAND AREA) (TEMPORARY TRAFFIC REGULATION) (NO.4) ORDER 2023

NOTICE IS HEREBY GIVEN that to enable Morrison Telecom Services to carry out utility works ("the Works"), Cumberland Council intends to make an Order the effect of which is to prohibit any vehicle from proceeding along the following sections of road:

1. Caldew Road, Cummersdale, from a point approx. 50m south east of its junction with Gilbert Road, extending in a south easterly direction for approx. 70m.

There is no suitable alternative route available for vehicles

2. Brisco Road, Carlisle, from a point approx. 1.7km north west of its junction with Newbiggin Road, extending in a north westerly direction for approx. 100m.

<u>Alternative Route</u>: via the unrestricted sections of Brisco Road, Newbiggin Road, Durdar

Road, Blackwell Road, Boundary Road and Upperby Road.

3. C1012 Houghton, from a point approx. 200m north east of its junction with the A689, extending in a north easterly direction for approx. 560m.

<u>Alternative Route</u>: via the unrestricted sections of the C1012, A689, A7 Carlisle Road, A6071 and the C1011.

Duration: From 28 November 2023 for approx. 2 days (Ref: TTROC/8799)

4. C2048 Hawksdale, near Dalston, from a point approx. 100m west of its junction with Nook Lane, extending in a westerly direction for approx. 125m.

Alternative Route: via the unrestricted sections of the C2048, B5299, The Green and the U1132

**Duration: From 29 November 2023 for approx. 2 days (Ref: TTROC/8805)** 

5. U1131 Nealhouse, Baldwinholme from appoint approx. 325m north west of its junction with the A595, extending in a north westerly direction for approx. 170m.

Alternative Route: via the unrestricted sections of the U1131, U1130 and the A595.

Duration: From 29 November 2023 for approx. 2 days (Ref: TTROC/8809)

6. C1042 near Newbiggin, from a point approx. 540m south of its junction with the B6143, extending in a south easterly direction for approx. 370m.

Alternative Route: via the unrestricted sections of the C1042, U3074 and the B6413.

Duration: From 5 December 2023 for approx. 2 days (Ref: TTROC/8874)

A way for pedestrians and dismounted cyclists will be maintained at all times

Nothing in the Order to which this notice relates shall:

- (i) Apply emergency service vehicles, or vehicles being used by statutory undertakers in the performance of their duties; and
- (ii) Apply to anything done with the permission or at the direction of a police constable in uniform; and
- (iii) Have the effect of preventing at any time access for pedestrians to any premises situated on or adjacent to the roads, or to any other premises accessible for pedestrians from, and only from the roads; and
- (iv)Apply to vehicles being used in connection with the Works.
