

CUMBERLAND COUNCIL (VARIOUS ROADS IN THE CUMBERLAND COUNCIL AREA)  
(TEMPORARY PROHIBITION OF ALL TRAFFIC) (NO.16) ORDER 2024

NOTICE IS HEREBY GIVEN that to enable highway works to be carried out (“the Works”), Cumberland Council intends to make an Order the effect of which is to prohibit all traffic (i.e. vehicles, pedestrians and cyclists), from proceeding along the following sections of road, specified in the attached Schedule.

Suitable diversion routes will be indicated on site by the display of relevant traffic signs as and when the temporary closures are in force. A way for pedestrians and dismounted cyclists will be maintained at all times.

The Order will come into operation on 13 May 2024 and may continue in force for a maximum duration of eighteen months. However, please note that it is anticipated that each restriction will only be required for 10 days within the 3 month period from 13 May 2024 to 23 August 2024, and only as and when the relevant traffic signs are displayed.

**SCHEDULE**  
**EXTENT OF RESTRICTIONS AND ALTERNATIVE ROUTES**

**1. U1184 Lambley Bank, Scotby (Ref: TTROC/10524)**

From its junction with Scotby Road, extending in a south westerly direction for approx. 450m.

There is no suitable alternative route available for vehicles.

**2. C1017 Southwaite (Ref: TTROC/10521)**

From its junction with the C1036, extending in a north easterly direction for approx. 1.13km.

Alternative Route: via the unrestricted section of the C1017, C1037, C3010 and C1036.

**3. B6413 Tarn Road, Brampton (Ref: TTROC/10506)**

From its junction with Tree Road, extending in a south easterly direction for approx. 2.25km.

Alternative Route: via the unrestricted section of the B6413, A686 Langwathby and Melmerby, A689, A69 and A6071.

**4. C1016 Rockcliffe (Ref:TTROC/10509)**

From its junction with C1022, extending in an overall southerly direction for approx. 3.36km.

Alternative Route: via the unrestricted sections of the C1016, C1015 and C1022.

**5. C1029 Walton (Ref:TTROC/10510)**

From its junction with the C1013, extending in an overall easterly direction for approx. 2.3km.

Alternative Route: via the unrestricted sections of the C1029, C1025, B6318 and C1013.

**6. C1029 Lanercost (Ref:TTROC/10511)**

From its northern junction with the C1025, extending in an overall southerly direction for approx. 4.7 km.

Alternative Route: via the C1025.

**7. U1122 Hoskethill ( Ref: TTROC/10516)**

From its junction with the C2042, extending in a south westerly direction for approx. 2.1km.

Alternative Route: via the B5307 Morrhouse, U1113 Monkhill and C2042.
