CUMBERLAND COUNCIL (VARIOUS ROADS IN THE CUMBERLAND AREA) (TEMPORARY TRAFFIC REGULATION) (NO.3) ORDER 2023

NOTICE IS HEREBY GIVEN that to enable Cumberland Council Highway Service to carry out highway works ("the Works"), Cumberland Council intends to make an Order the effect of which is to:

- 1. Prohibit any vehicle from proceeding along the lengths of road specified in the attached Schedule.
- To faciliate the alternative routes during the restriction detailed in item 7 of the Schedule, relating to the C1026 Cairn Bridge, near Heads Nook (Ref: TTRO/5125), vehicles will be prohibited from proceeding:
 - (i) Other than in a south westerly direction along that section of the C1035, from its junction with the C1024 extending in a south westerly direction for approx. 560m; and
 - (ii) Other than in a north westerly direction along that section of the U1197, from its junction with the C1035, extending in a north westerly direction to its junction with the C1024.

Suitable diversion routes will be indicated on site by the display of relevant traffic signs as and when the temporary closures are in force.

A way for pedestrians and dismounted cyclists will be maintained at all times.

Nothing in the Order to which this notice relates shall:

- (i) Apply to emergency service vehicles, or vehicles being used by statutory undertakers in the performance of their duties; and
- (ii) Apply to anything done with the permission or at the direction of a police constable in uniform: and
- (iii) Have the effect of preventing at any time access for pedestrians to any premises situated on or adjacent to the roads, or to any other premises accessible for pedestrians from, and only from the road; and
- (iv)Apply to vehicles being used in connection with the Works.

The Order will come into operation on 12 June 2023 and may continue in force for a maximum duration of eighteen months. However, please note that it is anticipated that the restrictions will only be required as detailed in the schedule, and only as and when the relevant traffic signs are displayed.

SCHEDULE EXTENT OF RESTRICTIONS AND ALTERNATIVE ROUTES

1. U1118 Bousted Hill - Approx. duration 12 days from 12 June 2023 (Ref: TTRO/4307)

From its junction with the B5307 extending in an overall northerly direction to its junction with the C2042.

Alternative Route: via the C2042, U2004 and B5307.

2. U1184 Scotby - Approx. duration 5 days from 26 June 2023 (Ref: TTRO/4308)

From its junction with the C1038, extending in a south westerly direction for approx. 850m.

There is no suitable alternative route available for vehicles.

3. C1027 Cumwhitton - Approx. duration 12 days from 19 June 2023 (Ref: TTRO/4636)

From its junction with the C1039, extending in an overall north westerly direction for approx. 2.2km.

Alternative Route: via the C1026 and C1039.

4. U1113 Beaumont - Approx. duration 12 days from 19 June 2023 (Ref: TTRO/4635)

From its junction with the U1111, extending in a south westerly direction for approx. 800m.

Alternative Route: via the C2042 Monkhill and the U1111Kirkandrews-on-Eden.

<u>5. C1003 Moor Road, Longtown - Approx. duration 5 days from 19 June 2023 (Ref: TTRO/4633)</u>

From a point approx. 400m north east of its junction with the A7, extending in a north easterly direction for approx. 2.2km.

<u>Alternative Route</u>: via the unrestricted sections of B5307 Newtown Road and Port Road, A595 Wigton Road and A689.

6. C1019 Park Road, Scotby - Approx. duration 12 days from 3 July 2023 (Ref: 4309)

From its junction with Montgomery Way, extending in an overall westerly direction for approx. 800m.

<u>Alternative Route</u>: via the unrestricted sections of Park Road, Scotby Road, A69 and Montgomery Way.

7. C1026 Cairn Bridge, near Heads Nook - Approx. duration 9 weeks from 10 July 2023 (Ref: TTRO/5125)

From its junction with the C1035, extending in a north westerly direction for approx. 1.25km.

Alternative Route for Eastbound Vehicles: via the unrestricted sections of the C1026, C1024 and C1035.

<u>Alternative Route for Westbound Vehicles:</u> via the C1035, U1197, C1024 and the unrestricted section of the C1026.

8. C1026 Cairn Bridge, near Heads Nook - Approx. duration 9 weeks from 10 July 2023 (Ref: TTRO/5125)

From its junction with the U1191 extending in a northerly direction for approx. 340m. <u>Alternative Route</u>: via the unrestricted sections of the C1026, C1027 and A69 Warwick Bridge.

9. B5307 Newtown Road, Carlisle - Approx. duration 12 days from 17 July 2023 (Ref: TTRO/3629)

From its junction with from its junction with Burgh Road to its junction with Berkeley Grange.

<u>Alternative Route</u>: via the unrestricted sections of B5307 Newtown Road and Port Road, A595 Wigton Road and A689.

10. C1020 Cumwhinton to Scotby - Approx. duration 12 days from 17 July 2023 (Ref: TTRO/4312)

From its junction with the C1040 Cumwhinton, extending in an overall northerly direction for approx. 2.2km.

<u>Alternative Route</u>: via the unrestricted sections of the C1020, C1038 Scotby to Wetheral and the B6263 Wetheral to Cumwhinton.
