

CUMBERLAND COUNCIL (VARIOUS ROADS IN THE DISTRICT OF CARLISLE)  
(TEMPORARY TRAFFIC REGULATION) (NO.3) ORDER 2024

NOTICE IS HEREBY GIVEN that to enable utility works to be carried out (“the Works”), Cumberland Council intends to make an Order the effect of which is to prohibit any vehicle from proceeding along the lengths of road specified in the attached Schedule.

Suitable diversion routes will be indicated on site by the display of relevant traffic signs as and when the temporary closures are in force.

A way for pedestrians and dismounted cyclists will be maintained at all times.

The Order will come into operation on 12 March 2024 and may continue in force for a maximum duration of eighteen months. However, please note that it is anticipated that the restrictions will only be required as stated in the schedule, and only as and when the relevant traffic signs are displayed.

**SCHEDULE**  
**EXTENT OF RESTRICTIONS AND ALTERNATIVE ROUTES**

**1. U1113 Monkhill – From 12 March 2024 for approx. 1 day (Ref: TTROC/9931)**

From its junction with the U1111 to its junction with the C2042.

Alternative Route: via the U1111 and C2042.

**2. C2042 Bowness-On-Solway – From 18 March 2024 for approx. 1 day (Ref:TTROC/9941)**

From its junction with the U7021 to its junction with the U2002.

Alternative Route: via the unrestricted sections of the C2042 and U2001.

**3. C1014 Durdar – From 28 March 2024 for approx. 1 day (Ref:TTROC/10007)**

From its junction with the C1017 to its junction with the U1148.

Alternative Route: via the unrestricted sections of the C1014, C1036 and C1017.

**4. U2244 Church Road, Angerton – From 19 March 2024 for approx. 1 day (Ref:TTROC/10009)**

From its junction with Birch Hill Lane, extending in a northerly direction for approx. 150m. There is no suitable alternative route available for vehicles.

**5. U1011 Longtown – From 21 March 2024 for approx. duration 1 day (Ref:TTROC/10012)**

From its junction with the C1001 to its junction with the C1006.

Alternative Route: via the C1001, U1012, U1013 and C1006.

**6. U1048 Lees Hill, Brampton – From 25 March 2024 for approx. 1 day (Ref:TTROC/10022)**

From a point approx. 280 metres north of its junction with the B6318, extending in a northerly direction for approx. 300m.

Alternative Route: via the unrestricted sections of the U1048, B6318 and U1047.
