### EXTENT OF RESTRICTIONS AND ALTERNATIVE ROUTES

### 1. A5084 Blawith – From 13<sup>th</sup> June 2025 for approx. 1 day (Ref:TTROW/14393)

From its junction with th U5080 extending in a predominately northerly direction to its junction with the U5082.

<u>Alternative Route</u>: via the unrestricted sections of the A5084 (Torver), A593 (Broughtonin-Furness), A595 (Grizebeck), A5092 (Woodgate) and C5018.

#### 2. C5091 Farleton – From 13th June 2025 for approx. 1 day (Ref:TTROW/14389)

From its junction with the A6070 extending in a north easterly direction to its junction with Baker's Lane.

Alternative Route: via the unrestricted section of C5091, A65 and A6070.

## <u>3. B6254 Oxenholme Road, Oxenholme – From 19<sup>th</sup> June 2025 for approx. 1 day (Ref:TTROW/14465)</u>

From its junction with Kendal Parks Road extending in a south easterly direction for a diatance of approx. 175m.

Alternative Route: via the unrestricted sections of the B6254, C5067and A65.

### 4. A593 Torver – From 30th June 2925 for approx. 1 day (Ref:TTROW/14557)

From its junction with the A5084 extending in a south westerly direction to its junction with Old Rake.

<u>Alternative Route</u>: via the unrestricted section of the A593 (Broughton-in-Furness), A595 (Grizebeck), A5092 (Lowick Green) and A5084.

#### 5. C5029 Bowland Bridge – From 1<sup>st</sup> July 2025 for approx. 2 days (Ref:TTROW/14574)

From a point approx. 315m in a predominately south of its junction with Smithy Lane, extending in a south easterly direction for a distance of approx. 680m.

<u>Alternative Route</u>: via the unrestricted sections of the C5029, C5048, C5060, C5047, and U5247.

## 6. U5607 Whetstone Lane, Helsington – From 3<sup>rd</sup> July 2025 for approx. 2 days (Ref: TTROW/14646)

From its junction with the C5062 extending in a south easterly direction for a distance of approx. 1.3km.

<u>Alternative Route Eastbound Traffic</u>: via the unrestricted section of Whetstone Lane, A591, A590, C5059 and C5062.

<u>Alternative Route Westbound Traffic:</u> via the unrestricted section Whetstone Lane, A591, A6, Gillingate, Bankfield Road, Brigsteer Road and C5062.

#### 7. U5561 Bridge Lane, Troutbeck Bridge – From 7<sup>th</sup> July 2025 for approx. 2 days (Ref: TTROW/14696)

From its junction with Hollbeck Lane extending in a south westerly direction for a distance of approx. 1.2km.

Alternative Route: via the unrestricted sections of Bridge Lane, A591 and Hollbeck Lane.

# 8. C5060 Bowland Bridge – From 10<sup>th</sup> July 2025 for approx. 1 day (Ref: TTROW/14723)

From its junction with Smithy Lane extending in a south easterly direction to its junction with Woodside Road.

Alternative Route: via the unrestricted sections of C5060, C5048, A5074 and C5047.
