EXTENT OF RESTRICTIONS AND ALTERNATIVE ROUTES

1. Kirkgate Lane, Milnthorpe – Start Date 19th May 2025 - Approx. duration 3 days (Ref:TTROW/14009)

From its junction with the A6, extending in a north easterly then south easterly direction for approx. 660m.

Alternative Route: via the A6 Church Street, Main Street and Haverflatts Lane.

2. Haverflatts Lane, Milnthorpe – Start Date 22nd May 2025 Approx. duration 3 days (Ref:TTROW/14011)

From its junction with the C5071, extending in a south westerly direction for approx. 490m.

Alternative Route: via the C5071 and Kirkgate Lane.

3. C5071 Ackenthwaite - Start Date 25th May 2025 - Approx. duration 4 days (Ref:TTROW/14015)

From its junction with the B6385, extending in a north easterly direction for approx. 1.1km. <u>Alternative Route</u>: via the B6385, A6 Church Street and the C5073 Woodhouse Lane.
