EXTENT OF RESTRICTIONS AND ALTERNATIVE ROUTES

1. U5452 Storth Road, Storth – Start Date 29th September 2025 - Approx. duration 3 weeks (Ref:TTROW/15628)

From its junction with from its junction with the U5451, extending in a south westerly direction for a distance of approx. 400m.

<u>Alternative Route</u>: via the U5451 Carr Bank Road, C5097 and the unrestricted section of the U5452 Storth Road.

2. U5451 Carr Bank Road, Storth – Start Date 29th September 2025 - Approx. duration 3 weeks (Ref:TTROW/15628)

From its junction with its junction with the C5097, extending in a north easterly then south easterly direction for a distance of approx. 1km.

Alternative Route: via the C5097 and the U5452 Storth Road.

3. C5060 Bowland Bridge - Start Date 20th October 2025 - Approx. duration 5 days (Ref:TTROW/15763)

From its junction with its junction with the C5048, extending in a north westerly direction for a distance of approx. 220m.

Alternative Route: via the C5048, A5074 and the unrestricted section of the C5060.

4. B5277 Lindale Road, Lindale - Start Date 1st October 2025 - (Ref:TTROW/14076)

From its junction with its junction Meathop Road, extending in a north westerly direction for a distance of approx. 2.1km.

Alternative Route: via the A590, B5278 and the unrestricted section of the B5277.

From a point adjacent to a property known as Far Kiln Bank, extending in a north westerly direction for a distance of approx. 95m.

From its junction with B5360, extending in a north easterly direction for a distance approx. 2.5km.
